1. _____ (initial) I understand that every effort is made to place only healthy animals and that HALO makes no guarantees regarding the nature, disposition or health of this animal. Not all animals have been examined by a veterinarian. I understand I should keep this animal separate from my current pets for 10 days to reduce the chance of spreading any contagious diseases the animal may be incubating. I also understand my pets at home should be current on vaccinations before introducing a new family pet.
2. _____ (initial) ANY medical bills incurred for any reason from this day forward for this animal will be the responsibility of the adopting party.
3. If adopting a cat, I agree to keep it indoors at all times to the best of my abilities unless I am supervising the animal outdoors.
4. I will take this animal to the veterinarian for booster vaccinations if needed, as well as yearly examinations and immunizations. I will not cosmetically alter this animal's appearance i.e. dock tail or crop ears.
5. I will always provide adequate food, water and shelter.
6. I will not transport the animal in the bed of a truck unless contained in a kennel.
7. I will not leave the animal in a vehicle when the outdoor temperature is above 70 degrees fahrenheit.
8. I will not, nor will I allow others to use this animal for experimental purposes.
9. I will allow a home visit by HALO personnel, and will surrender this animal if the HALO representative feels that the conditions are unsatisfactory.
10. _____ (initial) I understand that I have 10 days to exchange this animal for a voucher that will apply the original adoption fee towards another animal. HALO reserves the right to refuse to extend the offer of a voucher.
11. _____ (initial) I understand that if I need to return the pet I can contact HALO to inquire about returning the animal. If I rehome the pet on my own I will ensure the microchip and license information is updated with HALO and the manufacturer(s).
12. I assume all risks and responsibilities of ownership and indemnify HALO against any claims for damages including property and personal injury.
13. _____ (initial) I understand and agree that any sum I have given HALO is a donation toward their work in rescuing and caring for dogs and cats, and this donation is NOT REFUNDABLE. All returned checks will incur a \$25 returned check fee.
14. I understand and agree that any breach of paragraphs one through thirteen above constitutes grounds for HALO to rescind this contract, in which case ownership of this animal will revert to HALO. I agree to pay the court costs and reasonable attorney fees incurred by HALO in enforcing this contract.
15. HALO PARTNERSHIPS: At HALO, our mission work is made possible in part because of several important partnerships that help us save animal lives. HALO will provide base contact information for you to our partners in order that they may extend to you special offers and opportunities for you and your pet. HALO takes the privacy of all our adopters very seriously. HALO Animal Rescue

HALO Animal Rescue would like to advise its potential adopters of the three major viruses and infections that are commonly seen in a shelter environment and in post-adoption.

Canine Distemper Virus, (CDV), is a highly contagious viral disease of dogs and can affect them at any age. CDV may be misdiagnosed due to its wide range of clinical manifestations. Common symptoms are gastrointestinal, neurological and/or respiratory in nature. Dramatic and sporadic increases in body temperature are a telltale sign of the infection. Behavioral changes include lethargy and depression. Neurological signs include muscle twitching (especially near the mouth and legs) and possible seizures or paralysis. A skin sign in dogs with CDV is the hardening of footpads and nose pad most evident in older dogs. Sudden death is not uncommon with this disease.

Parvovirus Enteritis, or "Parvo", is characterized by vomiting, diarrhea, dehydration, dark and bloody feces, and in severe cases, fever and lack of appetite. Acute Parvovirus Enteritis can be seen in dogs of any breed, sex, or age. The disease will progress very rapidly and death can occur as early as two days after the onset of the disease. There is a broad range of severity of symptoms. Many adult dogs exposed to the virus show very few, if any, symptoms. The majority of cases of this disease are seen in dogs under 6 months of age with the most severe cases seen in puppies younger than 12 weeks of age.

Canine Infectious Respiratory Disease (CIRD), better known as "Kennel Cough", are characterized by a persistent cough, difficulty breathing, sneezing, and ocular or nasal discharge. The infection is highly contagious and can cause numerous respiratory problems in your pet. Pets left untreated can lead to pneumonia, lethargy, disinterest in food and water and a high fever.

If you observe any of these symptoms or if you ever suspect your pet is unwell, you should take your pet to a veterinarian immediately. Failure to initiate immediate treatment will significantly lower your pet's chance of survival.

HALO Animal Rescue will always ensure to uphold our facilities to the highest sanitation standards and make every effort to limit the spread of disease both in the maintenance of our kennels and through the vaccination of our pets. However there is no guarantee that can be made towards the health of the animal. There is always the risk that the pet you are adopting may have contracted a disease that they are not yet showing symptoms of. If you notice any of the symptoms listed on this page or suspect the pet may be unwell at the time of adoption, please bring this to the attention of your adoption counselor. Once the adoption is completed and the pet passes through our front doors, we can no longer provide any medical care for the pet and all treatments and medications become the sole responsibility of the adopter.

I hereby fully and completely release HALO Animal Rescue and its officers, employees, and agents from any claim, cause of action, damages, losses, costs, expenses and liabilities of any kind of nature. I assume all financial responsibility for any further treatment required and will not hold HALO responsible in any way. I agree to keep my new companion separate from all other pets for ten days, and where applicable I will keep my puppy from any public areas where there are other dogs until he/she is a minimum of 20 weeks old and fully vaccinated.

1. The pet I am adopting will not be ready to take home until after it is spayed or neutered.
2. I must pay the adoption fee in full today.
3. The adoption fee is a non-refundable donation to HALO Animal Rescue unless the pet does not survive surgery.
4. HALO estimates that the pet will be sterilized during the above time period, but unforeseen circumstances such as scheduling, illness or slow weight gain might prevent the pet from being spayed or neutered during this time frame.
5. I am responsible for picking up my new pet from HALO's shelter within 24 hours of receiving notification that the pet is ready to go home. Notification will be made via phone call to the number I provided above. HALO will leave a voicemail if there is a voicemail system available. If no voicemail system is available, HALO will attempt to reach me one more time. If I do not pick up the pet within 24 hours of the final call, the adoption fee is forfeit and the pet will go back up for adoption.
6. Medical costs for the pet become my responsibility after I pick up the pet.
